Day One

All aircraft offer superb cabin comfort with luxury leather interior and BOSE noise cancelling headsets. Our sleek and stable helicopters with a cruising speed of 245kph will give you an unforgettable view 500ft over Sydney Harbour before taking the scenic coastal route to Magenta Shores.

Golf at Magenta Shores Golf & Country Club with shared motorised carts

Magenta Shores Golf & Country Club is the only private golf course located on the Central Coast, boasting magnificent ocean views from the front 9 holes with the back 9 holes adjacent to the rainforest and National Parks.

The course conditioning should also be commended. Lush green couch fairways inspire confidence on approach shots, but are hard enough to provide sufficient run from the tee. LUGGAGE

PRICING

PAYMENTS
