Monday 10th May 2021

Self-drive to the Southern Highlands, NSW (approx. 1.5hrs from Sydney)

10:30am Meet, greet and warm up

11:00am 18 holes at Bowral Golf Club

Founded in 1901 and offering a fabulous country club feel, Bowral Golf Club is considered among the best country courses in NSW. With gently undulating fairways, this established course in old English style provides a test for all levels. The club's Signature Hole is the 5th with out of bounds down the full length of the right, a small bunkered green and a large Eucalypt, which makes for an interesting 2nd shot.

Check In **Links House Bowral 4***
2 Nights – Queen Room



Tuesday 11th May 2021

Morning Spend the morning at your leisure. We suggest taking some time to explore the many gorgeous homeware stores and cafes in Moss Vale.

11:00am Golf at Moss Vale Golf Club

The Moss Vale Golf Club is regarded as one of the prettiest courses in NSW, with avenues of pines, elms, gums and vividly coloured claret ash flanking the winding layout. A number of twists and turns, creek crossings and deceptive greens, make the course a true test. The creek which runs through the course has to be crossed 12 times during the round. From the clubhouse, the Moss Vale layout appears hilly, but after the opening five holes, it levels out and heads into the quiet countryside.



Wednesday 12th May 2021

This morning, check out of the hotel and spend the morning exploring Bowral and some of the other gorgeous Southern Highlands villages, before self driving to Goulburn (approx. 50mins)

1:00pm Visit to the National Trust managed Riversdale Homestead

Riversdale Homestead is a historic 1830's inn, purchased in 1875 by Edward Twynam who later became Surveyor General of NSW. Riversdale remained in his family until acquired by the National Trust in 1967. Standing within its original paddocks and outbuildings, Riversdale is a fine example of a Colonial Georgian home surrounded by splendid gardens and picnic grounds. Riversdale is renowned for its collection of fine Australian Colonial furniture and arts and craft.



Self drive to Canberra (approx. 1.25hrs)

Check In **East Hotel Canberra** – 4* - 2 nights

Situated between the vibrant shopping and restaurant hubs of Kingston and Manuka in Canberra's prestigious "Inner South", East Hotel is a contemporary, cool and vibrant apartment hotel offering visitors a unique Canberra experience. Thursday 13th May 2021

10:00am Golf at Royal Canberra Golf Club

Set in the picturesque Westbourne Woods arboretum, the variety of trees, including pines, birch and cedar as well as Australian natives, provides golfers with a sensory experience that matches anything the world of golf can offer.

The local mob of kangaroos and fantastic views of Lake Burley Griffin add to the occasion. The greens here are some of the largest in the country.



After Golf A visit to the National Arboretum



The National Arboretum features 94 forests of rare, endangered and symbolic trees from around Australia and the world. Many of the trees are still young but two of the forests are over 100 hundred years old. Over 44,000 trees from over 100 countries are growing across the huge 250 hectare (618 acre) site, making it one of the world's largest living collections of rare, endangered and significant trees.

Friday 14th May 2021

This morning, check out of the hotel before self driving to golf.

TBC Golf at The Federal Golf Club

Nestled at the base of Red Hill, the Federal course is set in beautiful bushland surrounds with grand views of the Brindabella Ranges. Native birds and animals flourish in the surrounding bush, and Kangaroos freely roam the course which comprises of many interesting and challenging long and short holes. The rolling fairways and a variety in elevation changes over the course, are a pleasure to play.

Water on eight holes and moderate bunkering. The Championship Hilltop course is 18 holes of bushland beauty, situated so that you can still hear the waves rolling in on the pristine Mollymook Beach.

Travel Insurance

Pricing

We will bring to your attention any change in price prior to you paying the balance of the tour. N.B some golf clubs, hotels, transfer companies and travel service providers reserve the right to increase their pricing due to increases in green fees, hotel

accommodation charges and currency fluctuations etc. Where the increase in price is greater than 10% of the original price of the tour, you may choose to either:

- (a) cancel the applicable booking without incurring any penalty; or
- (b) accept the change of price

You must notify the Golf & Tours of your choice within 14 days of receipt of notice of the increase or you will be deemed to have accepted the price change and will be liable for payment of the increase.

Payments

Golf & Tours accepts the following payment methods: Direct bank deposits, cheque and credit card (Visa, American Express or MasterCard N.B credit card payments will incur a 2.9% processing fee).

A deposit of \$300 per person is required to secure your place on this tour. Please indicate on the booking form how you wish to make this payment.

The balance will be due on 1st February 2021. On this day, Golf & Tours will contact, advising of the full amount owing for the tour, minus the deposit already paid, giving you the final balance owing. If you wish to make this final balance payment earlier than this date, please contact Golf & Tours Pty Ltd.

Cancellations & Refunds

Cancellations by the client must be in writing and are subject to the following forfeit of cost per person:

- Cancellation before final balance payment is required: Deposit lost
- Cancellation after final balance payment has been completed: 100% of the tour cost charged

If the company is forced to cancel a tour due to minimum numbers not being reached, a full refund or option to transfer full deposit to a subsequent tour will be offered to the client. This does not include Force Majeure.

Force Majeure

Force Majeure means the occurrence of an event that is beyond Golf & Tours' reasonable control and which could not have been reasonably prevented by Golf & Tours which includes, but is not limited to: (a) war, armed conflict, criminal damage, riot, civil strife, industrial dispute, terrorist activity or the threat of any such acts; (b) natural disaster (including but not limited to flooding, fire, earthquake, landslide, pandemic), adverse weather conditions, high or low water levels; (c) nuclear or other industrial accident causing environmental pollution or contamination; or (d) change in law, meaning, enactment, amendment (including repeal) in the law or administration of any law in Australia or any jurisdiction or territory relevant to the booking contract, which includes changes in statute, regulation, determination, by-law, declaration, licence and the common law as applicable from time to time.

Termination of Booking Contract or Change of Travel Arrangements due to Force Majeure

If Golf & Tours in its reasonable opinion, considers that any Force Majeure event prevents Golf & Tours (whether directly or through its employees, contractors, subcontractors and agents) from lawfully or safely providing any products or services subject of the booking contract with you, Golf & Tours may immediately by written notice: (a) terminate the booking contract (in whole or in part); or (b) change your travel arrangements as reasonably practicable to ensure your safety and invoice you for any additional costs.

Limitation of Liability in the Event of Force Majeure

In the event of a force majeure event making it impossible or unsafe for Golf & Tours to deliver all or part of the Tour Package, Golf & Tours reserves the rights to postpone the tour to new dates. If these rescheduled dates do not suit the client, Golf & Tours will offer a credit voucher to the full value they have paid for the postponed trip, to be used on a future tour (within 12 months of original tours departure date).
